WHEREAS, on 29 December 2023, the Board of Directors, as Head of the Procuring Entity (HOPE), approved the Annual Procurement Plan for the CAPEX 2024 requirements of Coconut Industry Investment Fund - San Pablo Manufacturing Corporation (SPMC), Granexport Manufacturing Corporation (GRANEX) and Legaspi Oil Company, Inc. (LEGOIL) upon favorable recommendation of the Bids and Awards Committee I (BAC 1);

WHEREAS, the above Annual Procurement Plans contains the "PROCUREMENT OF SUPPLY AND INSTALLATION OF VARIOUS AIR CONDITIONING UNIT WITH ELECTRICAL WIRING AND OUTLET" for SPMC, GRANEX, LEGOIL;

WHEREAS, SPMC is the procuring arm for the procurement of the above-mentioned project;

WHEREAS, the aggregated Approved Budget for the Contract (ABC) of the abovementioned project is One Million Four Hundred Five Thousand Two Hundred Thirteen Pesos and 49/100 (Php 1,405,213.49), and shall be undertaken through Competitive Bidding;

WHEREAS, during the pre-procurement conference (held on 27 August 2024 and 28 August 2024, the Bids and Awards Committee IV (BAC 4) adopted the recommendation of the Technical Working Group to proceed with the public bidding for the procurement of SUPPLY AND INSTALLATION OF VARIOUS AIR CONDITIONING UNIT WITH ELECTRICAL WIRING AND OUTLET for SPMC, GRANEX and LEGOIL;

WHEREAS, the BAC 4, through its Secretariat, advertised and published the Invitation to Bid (SPMC-2024-020) for seven (7) calendar days from the date of its posting on September 5, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number 11217572); (2) the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation website; and (3) conspicuous places at the premises of the SPMC, GRANEX and LEGOIL;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

WHEREAS, during the post-qualification of the submitted bid on October 7, 2024 to November 12, 2024 and after examination, validation and verification of all eligibility, technical and financial requirements of NEXUS Electrical Network Solution Inc and Vinno Venture Solutions, Inc., the TWG observed that both bidders failed to comply with the bidding requirements which is attached hereto as Annex "E" and "F";

WHEREAS, the BAC 4 adopted the recommendation of the TWG to declare NEXUS Electrical Network Solution Inc and Vinno Venture Solutions, Inc as post-disqualified due to failure to comply with the bidding requirements;

WHEREAS, on 12 November 2024 the BAC 4, with the assistance of the Technical Working Group, conducted a Bid Evaluation of the bid proposal of Bigcrate Enterprises, Inc. being the next rank/ Highet Calculated bidder
