Recommending the Award of Contract for the Procurement of Bunker Fuel for San Pablo Manufacturing Corporation

Project Number: SPMC-NP-2FB-2024-002 (PhilGEPS# 10948971)

WHEREAS, on 03 June 2024, the Bids and Awards Committee I (BAC 1) issued its Resolution No. SPMC-2024-003B-BAC1-01 declaring the 2nd failure of bidding for the Procurement of Bunker Fuel” for San Pablo Manufacturing Corporation due to non-receipt of bids;

WHEREAS, during the pre-procurement conference (held on June 11, 2024), the Bids and Awards Committee I (BAC 1) adopted the recommendation of the Technical Working Group (TWG) to proceed with the Negotiated Procurement – Two Failed Biddings for the procurement of Bunker Fuel for San Pablo Manufacturing Corporation;

WHEREAS, the Approved Budget for the Contract (ABC) of the abovementioned project is Four Million Two Hundred Thirty-Five Thousand Pesos (Php 4,235,000.00);

WHEREAS, the BAC 1, through its Secretariat, advertised and published the Request for Quotation (SPMC-NP-2FB-2024-002) for seven (7) calendar days from the date of its posting on June 13, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number **10948971**); (2) the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Negotiation Conference, Opening of Quotation, Evaluation and Post-Qualification;

WHEREAS, the BAC 1 conducted a Pre-Negotiation Conference on June 20, 2024 via Zoom through link Meeting ID 870 4291 8446 595530. However, no prospective bidders and observers attended the Pre-Negotiation Conference;

WHEREAS, on June 27, 2024 - the scheduled opening of quotations, the BAC 1, as certified by the Secretariat, received one (1) quotation for the abovementioned procurement activity, to wit:

However, no observers attended the scheduled opening of quotation.

WHEREAS, Darcy and Anna Builders and Trading, the lone bidder, passed the preliminary examination of quotation;

WHEREAS, on June 28, 2024, the BAC 1, with the assistance of Technical Working Group, conducted the Evaluation and Post-Qualification of the Supplier's Quotation;

WHEREAS, the price quotation below was found to be substantially complying:
