Recommending the Award of Contract for the Procurement of Automotive Diesel Oil (Diesoline) for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.

**Project Number: SPMC-2024-002 (PhilGEPS# 10735016)**

**WHEREAS**, on 22 February 2024, the Board of Directors, as Head of the Procuring Entity (HOPE), approved the Supplemental Annual Procurement Plan Number of San Pablo Manufacturing Corporation (SPMC-SAPP-2024-001) and Granexport Manufacturing Corporation (GMC-SAPP-2024-001) and Legaspi Oil Company, Inc. Annual Procurement Plan (LEG-APP-2024) for the Coconut Industry Investment Fund – Oil Mills Group upon favorable recommendation of the Bids and Awards Committee (BAC);

**WHEREAS**, the above procurement plans contain the “PROCUREMENT OF AUTOMOTIVE DIESEL OIL (DIESOLINE) for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.” with an aggregated approved Budget for the Contract (ABC) amounting to Nineteen Million Six Hundred Eight Thousand One Hundred Eighty-Two Pesos and 52/100 (Php 19,608,182.52), and shall be undertaken through Competitive Bidding;

**WHEREAS**, the detailed ABC is as follow:

**WHEREAS**, during the pre-procurement conference (held on April 4-5, 2024), the Bids and Awards Committee I (BAC 1) adopted the recommendation of the Technical Working Group to proceed with the public bidding for the procurement of Automotive Diesel Oil (Diesoline) for San Pablo Manufacturing Corporation, Granexport Manufacturing Corporation and Legaspi Oil Company, Inc.;

**WHEREAS**, the BAC 1, through its Secretariat, advertised and published the Invitation to Bid (SPMC-2024-002) for seven (7) calendar days from the date of its posting on April 8, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number **10735016**); (2) the Coconut Industry Investment Fund – Oil Mills Group website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – Oil Mills Group;

**WHEREAS**, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PPCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening of and Post-Qualification;

**WHEREAS**, during the scheduled Pre-Bid Conference on April 16, 2024 via Zoom through link Meeting ID 836 9882 1655 430766 and were attended by the following:
