**Declaration of Failure of Bidding for the Procurement of Various Food Additives for San Pablo Manufacturing Corporation**

**Project Number: SPMC-2024-018B (PhilGEPS# 11327194)**

**WHEREAS**, on 06 September 2024, the Bids and Awards Committee I (BAC 1) issued its Resolution No. SPMC-2024-018-BAC1-01 declaring the failure of bidding for the Procurement of Various Food Additives for San Pablo Manufacturing Corporation due to ineligibility of the bidder;

**WHEREAS**, during the pre-procurement conference (held on October 4, 2024), the Bids and Awards Committee I (BAC 1) adopted the recommendation of the Technical Working Group (TWG) to proceed with the 2<sup>nd</sup> public bidding for the procurement of Various Food Additives for San Pablo Manufacturing Corporation;

**WHEREAS**, the aggregated approved Budget for the Contract (ABC) is Seven Million Eight Hundred Forty Thousand Five Hundred Sixty-Eight Pesos and 76/100 (Php7,840,568.76);

**WHEREAS**, the detailed ABC is as follows:

**WHEREAS**, the BAC 1, through its Secretariat, advertised and published the Invitation to Bid (SPMC-2024-018B) for seven (7) calendar days from the date of its posting on October 7, 2024 on the following: (1) the PhilGEPS Web Portal (Reference Number 11327194); (2) the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund – San Pablo Manufacturing Corporation;

**WHEREAS**, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PCCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

**WHEREAS**, the BAC 1 issued a Supplemental Bid No. 11327194-01 for the postponement of pre-bid posted on October 11, 2024 due to the declaration of suspension of work in government agencies in Pasay and Manila due to opening of APMCDRR, which is attached hereto as Annex “C” and posted the same in the manner prescribed by pertinent laws;

**WHEREAS**, the BAC 1 conducted a Pre-Bid Conference on October 17, 2024 via Zoom through link Meeting ID 839 0886 6168 997217 and was attended by:

**WHEREAS**, the BAC 1 issued the Supplemental Bid No. 11327194-02 for the postponement and re-scheduling of the submission and opening of bids in line with the issued Supplemental Bid No. 1 which is attached hereto as Annex “B” and posted the same in the manner prescribed by pertinent laws;

**WHEREAS**, the BAC 1, as certified by the Secretariat, received one (1) bid proposal for the above-mentioned procurement activity, to wit:

- d) After the conduct of mandatory review, to **DIRECT** the BAC Secretariat to Re-Bid and/or resort to Negotiated Procurement in accordance with Section 53 of the 2016 Revised IRR of RA 9184.
