WHEREAS, on 06 August 2024, the Bids and Awards Committee III (BAC 3) issued its Resolution No. GMC-2024-007B-BAC3-01 declaring the 2nd failure of bidding for the Procurement of Jacketing and Re-toothing of Intermediate Gears" for Granexport Manufacturing Corporation due to ineligibility of the bidder;

WHEREAS, during the pre-procurement conference (held on September 12, 2024), the BAC 3 adopted the recommendation of the Technical Working Group (TWG) to resort to Negotiated Procurement – Two Failed Biddings for the procurement of Jacketing and Retoothing of Intermediate Gears for Granexport Manufacturing Corporation;

WHEREAS, the aggregated Approved Budget for the Contract (ABC) is Two Million Eight Hundred Eighty-Six Thousand Two Hundred Thirteen Pesos (Php 2,886,213.00);
