**Recommending the award of contract the Procurement of Various Welding Electrodes for
Granexport Manufacturing Corporation**

Project Number: GMC-2024-012B (PhilGEPS# 11179501)

WHEREAS, on 05 August 2024, the Bids and Awards Committee III (BAC 3) issued its Resolution No. GMC-2024-012-BAC3-01 declaring the failure of bidding for the Procurement of Various Electrodes for Granexport Manufacturing Corporation due to ineligibility of the bidder;

WHEREAS, during the pre-procurement conference (held on 21 August 2024, the Bids and Awards Committee III (BAC 3) adopted the recommendation of the Technical Working Group to proceed with the 2nd public bidding for the procurement of Various Welding Electrodes for Granexport Manufacturing Corporation;

WHEREAS, the aggregated Approved Budget for the Contract (ABC) of the abovementioned project is Two Million Three Hundred Fifty-Seven Thousand Nine Hundred Ten Pesos and 45/100 (Php 2,357,910.45);

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PPCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening, Bid Evaluation and Post-Qualification;

WHEREAS, the BAC 3 conducted a Pre-Bid Conference on August 30, 2024 via Zoom through link Meeting ID 927 3997 8020 199828 and was attended by:

WHEREAS, the following passed the preliminary examination of bids;

WHEREAS, upon ranking of the total bid prices as calculated, the submitted bid of Industrial Welding was identified as the Single Calculated Bid, as read, for lots 1, 2 and 3 while Sellchem Global Trading Inc. was identified as the Single Calculated Bid, as read for lot 4. Both bids are subject to bid evaluation.

WHEREAS, on September 12, 2024 the BAC 3, with the assistance of the Technical Working Group, conducted a Bid Evaluation of the bid proposal of the bidders;

WHEREAS, the bids proposal below were found to be substantially complying:
