Luna St., Intramuros, Manila, represented here by its President and Chief Executive Officer, CARLO LUIS P. RABAT duly authorized for this purpose under Board Resolution _____, Series of_____ (copy of which is attached as Annex A).

WHEREAS, The Entity invited Bids for certain goods and ancillary services, particularly the Procurement of 1-Unit Near Infrared Reflectance (NIR) for LEGOIL and has accepted a Bid from DAKILA for the supply of those goods in the sum of FOUR MILLION SEVEN HUNDRED FIFTY-SEVEN THOUSAND NINE HUNDRED FIFTY PESOS (Php 4,757,950.00) (hereinafter called "The Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
