Luna St., Intramuros, Manila, represented here by its President and Chief Executive Officer, CARLO LUIS P. RABAT, duly authorized for this purpose under Board Resolution _____, Series of _____ (copy of which is attached as Annex A).

ALPHATECH DEVELOPMENT CORPORATION ("ALPHATECH") a corporation organized under Philippine laws with principal office address at Penthouse 1853 Taft Avenue, Malate, Manila, represented here by AURELIO T. MEDINA, JR. Authorized Representative authorized for this purpose under Resolution No._____Series of____(copy of which is attached as Annex B);

WHEREAS, The Entity invited Bids for certain goods and ancillary services, particularly the Procurement of 50,732pcs PE Container for Minola 3.5 Liters with Caps for SPMC and has accepted a Bid from ALPHATECH for the supply of those goods in the sum of ONE MILLION SIX HUNDRED TWENTY ONE THOUSAND NINE HUNDRED TWO AND 4/100 PESOS (Php 1,621,902.04) (hereinafter called "The Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
