

CONTRACT AGREEMENT

This Agreement is executed on 09 December 2024 at Intramuros, Manila between:

GRANEXPORT MANUFACTURING CORPORATION ("GRANEXPORT") is a non-chartered government-owned and controlled corporations (GOCC) and one of the six (6) oil mill/refinery companies comprising the Coconut Industry Investment Fund-Oil Mills Group (CIIF-OMG) holding office at 4th Floor Palacio Del Gobernador, Gen. Luna St., Intramuros, Manila, represented here by its President and Chief Executive Officer, CARLO LUIS P. RABAT duly authorized for this purpose under Board Resolution _____, Series of _____ (copy of which is attached as Annex A).

JMA MACHINERY PARTS SUPPLIER ("JMA"), a corporation organized under Philippine laws with principal office address at Lot15 Blk1 Homepoint Village Brgy. San Isidro Angono Rizal represented here by JANUS MIGUEL C. AQUINO, Sales Manager and Authorized Representative authorized for this purpose under Resolution No. _____ Series of _____ (copy of which is attached as Annex B);

WHEREAS, The Entity invited Bids for certain goods and ancillary services, particularly the Procurement of Various Parts of Viking Pump for Granexport and has accepted a Bid from JMA for the supply of those goods in the sum of **THREE HUNDRED SEVENTY THOUSAND FIVE HUNDRED FIFTY AND 40/100 PESOS (PHP 370,550.40)** (hereinafter called "The Contract Price"), which is broken down on a per item basis, as follows:

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
