**Recommending the Award of Contract for the Procurement of Manpower Services for
Granexport Manufacturing Corporation**

Project Number: GMC-2026-001 (PhilGEPS# 12734156)

WHEREAS, on 16 January 2026, the Board of Directors, as Head of the Procuring Entity (HOPE), approved the Annual Procurement Plan Y2026 for Granexport Manufacturing Corporation (GRANEX) upon favorable recommendation of the Bids and Awards Committee I (BAC 1);

WHEREAS, the Approved Budget for the Contract (ABC) of the abovementioned project is Fifty-Eight Million Four Hundred Sixty-Four Thousand Nine Hundred Thirty-Four Pesos and 22/100 (P58,464,934.22));

WHEREAS, during the pre-procurement conference (held on 19 January 2026 to 20 January 2026), the BAC 1 adopted the recommendation of the Technical Working Group to proceed to the procurement of Manpower Services for Granexport Manufacturing Corporation through public bidding modality;

WHEREAS, the BAC 1, through its Secretariat, advertised and published the Invitation to Bid (GMC-2026-001) for seven (7) calendar days from the date of its posting on January 21, 2026 on the following: (1) the PhilGEPS Web Portal (Reference Number **12734156**); (2) the Coconut Industry Investment Fund - Granexport Manufacturing Corporation website; and (3) conspicuous places at the premises of the Coconut Industry Investment Fund - Granexport Manufacturing Corporation;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised IRR of RA9184, the invitation to observers from Commission on Audit (COA), Philippine Chamber of Commerce, Inc. (PPCI) and Transparency and Accountability Network (TAN) were served together with the schedule of Pre-Bid conference, Bid Opening of and Post-Qualification;

WHEREAS, the BAC 1 conducted a Pre-Bid Conference on January 29, 2026 via Zoom through link Meeting ID 867 7307 4827 834352 and were attended by the following:

However, it was noted that there were no observers present on the scheduled Pre-Bid Conference.

WHEREAS, to address the issue raised during the Pre-Bid Conference, the BAC 2 issued Bid Supplemental No.1 (with reference no. 12734156-01) posted on February 3, 2026, which is attached hereto as Annex "A" and posted the same in the manner prescribed by pertinent laws;

WHEREAS, the BAC 2, as certified by the Secretariat, received one (1) bid proposal for the above-mentioned procurement activity, to wit:
